#### **Learning Outcomes**

Please describe the learning outcomes of the course: Knowledge, skills and abilities acquired after the successful completion of the course

The purpose of this course is to introduce students to social work theory and practice through an exploration of the history, philosophical foundation and theoretical perspectives of the profession of social work. This includes a review of the relevant codes of ethics, principles, practice standards that guide practitioners and core competencies related to engagement, assessment, intervention and evaluation with individuals, families, groups, organizations and communities from vulnerable and marginalized populations in society, as well as an overview of the roles in which social workers become involved in different fields of practice such as health care and mental health, child welfare, education, etc.

On successful completion of this course students will:

- Have developed a historical perspective of the origin, values and the ideological influences which have shaped social work generally and in Greece in particular.
- Gain an understanding of theories and practice approaches that inform social work practice (generalist, structural, anti-oppressive, anti-racist, etc.) and analyze the contexts within which social work is practiced (individuals, families, groups, communities, research, and policy).
- Have learnt some of the key skills of social work, which are imperative for successful professional practice as well as the ethical standards of the profession in working with client systems, agency personnel and colleagues.
- Demonstrate awareness and understanding of complexities of human diversity and key issues in social work (e.g. poverty, oppression, gender, housing, health, sexuality,







disability, race, etc.) and the range of methods and strategies needed for effective practice.

## Alternative ways of examining a course in emergency situations

Implementation Instructions: (3)	Examination will be held according to the Examination Program announced by the Department. The exam will be held online, through the electronic platform of e-class. Those students who have been enrolled on the course and are aware of long distance education conditions, are allowed to take the examination. On the day and time of the examination, student must connect in groups on the electronic platform of e class, and choose the option Tasks from the column Active tools on the left, where they will find the relevant unit about the course exam. After they read and answer the questions, they will upload their answers on a single word doc, not later than the time provided, by pressing Submit Task and then Choose file. Before they upload the file with their answers, they must save their full name and register number. On their answers they must also write their full name, father's name, semester and register number. Those students who are examined orally, will contact the instructor through personal message.
