2. LEARNING OUTCOMES

Learning Outcomes

Please describe the learning outcomes of the course: Knowledge, skills and abilities acquired after the successful completion of the course.

The course aims to familiarize students with the perspective and applications of radical, anti-racist, feminist and other theories that constitute critical social work and draw on critical theories, such as Marxism, Feminism, etc. It highlights their influence both in social work education and practice, focusing on specific social groups and minorities, such as the poor, people with disabilities, women, etc. It also focuses on issues of discrimination, inequality, oppression, otherness etc, as well as on concepts and values, such as social justice and human rights, social change, empowerment and collective action. Additionally, the course offers an overview of the prospects, the limits and possible obstacles in the application of critical social work in Greece. Emphasis is also placed on issues related to the concept of minority. Part of the lectures focuses on the case of the Muslim minority in Thrace, especially in identity issues, educational and socioeconomic policies, as well as in examples of social work interventions in disadvantaged minority communities in Thrace.

On successful completion of this course students will:

• Have developed a historical perspective of the factors that favoured the emergence of the various critical approaches developed by social work, especially in the Anglo-Saxon countries.







 Gain an understanding of the key assumptions and ideological principles of the different approaches of critical social work, which, in contrast to the "traditional" approaches, recognize the role of broader structural and social factors and processes, especially with regard to issues of social class, gender and "race".

• Be able to critically assess the strengths and weaknesses of the different approaches of critical social work as well as the limitations and possibilities of their application, especially in Greece.

• Have learnt some of the key skills, techniques and models of intervention (development of cooperative and non-authoritarian relationships between social workers and targets, reflective practice, pursuit of goals of social change, etc.) used in the application of critical social work in practice.

- Gain an understanding of the different approaches to the term 'minority'.
- Demonstrate awareness and understanding of the key issues that social workers should take into account when intervening in minority communities, groups and individuals.
